

Chadotel Contest Rules

"Camping Stay for New Year's Gifts"

Article 1: Organizer

The contest is organized by Chadotel, whose registered office is located at 54 rue Georges Clemenceau, 85520 JARD SUR MER - FRANCE, registered under the RCS number 388334526.

Article 2: Contest Duration

The contest will take place from January 5, 2025, to January 8, 2025, at midnight local time. Any participation after this date will not be considered.

Article 3: Eligibility

This contest is open to any individual aged 18 or older who has an active Instagram and/or Facebook account.

The contest is free to enter and requires no purchase.

Participation is limited to one entry per person, per Instagram and/or Facebook account.

Article 4: How to Participate

To participate in the contest, the following steps must be completed:

- Follow @Chadotel on Instagram and/or Facebook.
- Like the contest post.
- Tag 2 friends in the comments of the contest post.
- Optional: Share the post in your story.

Participants must complete all mandatory steps for their entry to be valid. Incomplete entries will be disqualified automatically.

Article 5: Prize

The winner will receive a gift code worth €500, redeemable for a stay in one of Chadotel's campsites in 2025 (excluding the period from August 2 to August 31, 2025), subject to availability.

The prize amount is non-refundable, non-transferable, and cannot be exchanged for cash.

Article 6: Winner Selection

A random draw will be conducted among all participants who have met the participation requirements. The draw will take place on January 9, 2025, under the supervision of Chadotel's management.

Article 7: Winner Announcement

The winner will be announced on Chadotel's Instagram and Facebook pages on January 10, 2025, via a post or story. The winner will also be contacted via private message on Instagram and/or Facebook to notify them of their prize and to request their details for prize delivery.

Article 8: Prize Delivery

The €500 voucher will be awarded to the winner within 15 days after verifying their contact information. Detailed instructions on how to book and redeem the prize will be provided to the winner via private message.

Article 9: Liability

The organizer reserves the right to cancel or modify the contest in the event of force majeure or for any other reason beyond its control, without liability.

The organizer will not be held responsible for the loss, theft, or damage of the prize once it has been awarded to the winner.

If the winner does not claim the prize within 30 days of the announcement, it will be considered forfeited and will not be reallocated.

Article 10: Protection of Personal Data

Personal data collected during the contest will be used solely for the purpose of administering the contest (e.g., drawing, contacting participants) and will not be shared with third parties.
